CEO SESSION David Swank

MISCELLANEOUS

David Swank reminded the board that Central would receive an award at the April 12, Meridian Technologies' Partners for Progress event. He also reported Central is included in articles in the current RE Magazine and Public Utilities Fortnightly magazines.
